### NEW! Retroactive to 1/1/2020.

OTC medications like Tylenol®, Zyrtec®, and more will now be available for purchase with an FSA without a prescription.

### *Who Can I Use This Account For?*

Dependents that live with you while you are at work. While this most commonly means child care for dependent children up to age 13, it can also be used for adult day care for senior citizen dependents that live with you, such as parents.

### *The Following Dependent Care Expenses are **Not** Eligible for Reimbursement*

- Over Night Camps
- Educational Expenses for Kindergarten and above
- Amounts Paid to Your Dependent for Childcare
